This has reference to your application dated 29 September 2011 which was received at the College on 11 October 2011 seeking information under RTI Act 2005.

The replies to your queries are given hereasunder:

The minutes of the Selection Committee meeting dated 27 January 2009 cannot be provided as the matter pertains to the confidentiality of the selection process for appointment of Lecturer re-designated as Assistant Professor

Mr. Akhilesh Kumar was recommended for appointment as Lecturer in English by a duly constituted Selection Committee which met on 27.01.2009. Since he was pursuing M.Phil (The minimum qualification for appointment as Lecturer in Colleges, as per norms of the University applicable at the time of the meeting of the Selection Committee), the Selection Committee recommended relaxation from NET or M.Phil for two years for which necessary approval from University of Delhi and University Grants Commission was to be sought. Though the University Grants Commission granted exemption from NET in respect of the Sh. Akhilesh Kumar (VH) received on 25.03.2010 at the College. The approval from NET in respect of Sh. Akhilesh Kumar (VH) was subsequently withdrawn by University Grants Commission, copy of which was received from University vide letter no. CB-I/(H)/NET-Exemption/2010/148/17858 dated 09/12.07.2010.
