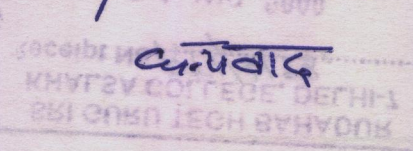


Dear Sir,

This has reference to your application dated 2.8.2009 received at the College on 06.08.2009 seeking information regarding teaching of Urdu at the College under RTI Act.

The replies to your queries are given as under:

1. It is submitted that the post of Lecturer in Urdu was advertised in national dailies in May 2006. The appointment against the post could not be made because there were not sufficient students in the subjects and as per UGC guidelines appointment of a teacher cannot be made in the absence of adequate workload.
2. The post of Lecturer in Urdu was not advertised after May 2006 in view of reasons mentioned above
3. A permanent teacher taught subject (Urdu) at the College till the academic session 1990-91 . Adhoc / Guest arrangements were made for teaching of the subject till the academic session 2004-05. In spite of best efforts on the part of the College, the students willing to study the subject have not been approaching the College for enrolment in Urdu. The institution never denied admissions to students willing to study Urdu
4. The Governing Body of the College or the faculty has no objections to appointment of teacher in the subject at the College provided there is sufficient work-load in the subject as per UGC guidelines.

Educational Qualifications

1. Good academic record with at least 55% marks (50% for candidates belonging to SC/ST or those who passed their Master's Degree prior to 19.09.1991 and hold a Ph.D. Degree) or an equivalent grade B in the seven point scale with letter grade O, A, B, C, D, E and F at the Master's Degree level in the relevant subject from an Indian University or an equivalent degree from a foreign University.
2. Candidates should have cleared the National Eligibility Test (NET) for Lecturers conducted by the UGC / CSIR or similar test accredited by the UGC.

NOTE

- (a) Candidates who have completed M.Phil. Degree by 31st December, 1993 or have submitted Ph.D. Thesis in the concerned subject up to 31st December, 2002 are exempted from qualifying NET.
- (b) A relaxation of minimum marks at the PG level from 55% to 50% may be provided to the candidates who have cleared the J.R.F. examination conducted by the UGC/ CSIR only, prior to 1989, when the minimum marks required to appear for J.R.F. examination were 50%.
- (c) The above eligibility conditions are subject to revision, if any, by the University of Delhi.
- (d) Candidates already in service should apply through proper channel.
- (e) 3% reservation for physically handicapped candidates (1% each for persons who are blind or low vision, hearing impaired and locomotor disabled) Persons having more than 40% disability are eligible for the post(s). Age relaxation and relaxation of eligibility shall be as per rules, in force.
- (f) The candidates belonging to SC/ ST should mention the category specifically in their application forms.

The Applications should reach the College Office by 2.30 P.M. on 10.06.2006 or before and envelope should be superscribed "APPLICATION FOR THE POST OF LECTURER IN _____"
