Respected sir,

I put a RTI earlier, Ref. No. - RTI/545-A, but I was not satisfied with your reply. If, by chance, again this time I will not be satisfied with your reply than I will may move to the court with a thought that injustice was done with me (As I was the real owner of ~~year~~ B.A. Prog academic topper award but because of your self made rules I didn't get it). My questions are:

1. What are the various rules by which even a high scorer student can be exempted from getting toppers award? (Like a student with an ER cannot get that prize even if his/her marks are highest or, a student with a year gap). Is there any other such rule like this for disqualifying a highest scorer?
2. Are these rules same for first, second and third year student or different?
3. I asked in my last RTI, Ref. no. 545-A that if a student got an ER in his/her final year and then he clear it in next year (4th yr) before finalisation of toppers list and scored highest. Will he/she get the topper award? If not, due to which rule?

(You said in last reply that this matter does not fall under RTI act & hence cannot be replied)
But you disqualified me for award due to this reason (ER in final year). I want that rule of disqualification in written with explanation & it comes under RTI act.

④ Is this rule for first, second and third year student? or some kind of relaxation is given to first and second year student?

⑤ What you do with awards of toppers who couldn't come to take their annual function award on annual day due to some reasons? Will they get their prize if they come to college after six month or a year? Do you try continuously to contact them to take their award?

I am submitting a postal order of ₹ 10 as fee.

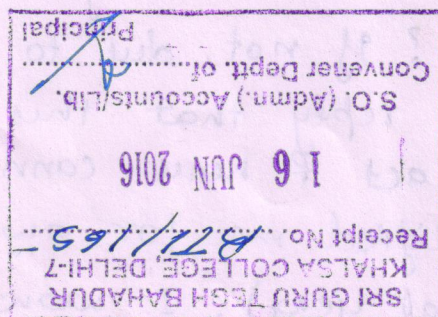
If the above asked information does not belong to you or your department then please handed-over my application to the concerned person or authority within 5 days under section 6(3) of RTI act 2005.


