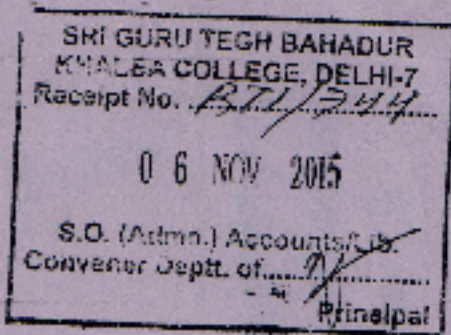


This has reference to your application dated 06.11.2015 seeking therein information under RTI Act 2005. The reply to your queries are provided hereunder:
