Dear Sir,

This has reference to your letter no. ARDP/RTIL/2014 dated 25 July 2014 seeking information under RTI Act 2005 regarding appointment of teaching staff under Persons with Disabilities (PWD) category. The replies to your queries, point wise are being given hereasunder:

1. The total sanctioned teaching posts as on as 25.07.2014 is 150
2. 76 (Seventy Six) appointments have been made against teaching posts since 1994
3. 03 appointments were made against handicapped category (02 OH, 01-VH)
4. 03 persons were appointed against PWD posts. Another teacher, who had a serious accident and suffered dysfunctioning of lower portion, permanently on wheel chair is also on the rolls of College against a permanent post. One OH permanent teacher, has been sanctioned EOL with lien to enable him to join as Associate Professor, Department of History, University of Delhi
5. The OH appointees were allotted points no. 24 and 37 in the old Roster
- 6, 7, and 8 01 candidate was appointed against VH category subject to approval from UGC from exemption in NET. A copy of the advertisement inviting applications for one teaching post, reserved for VH was given in 'The Hindustan Times' on 28.10.2008. The post was allotted point no. 74 in the roster
9. No fresh appointments have been made and as such the Selection Committee Reports cannot be supplied. The College follows 100 Points Roster. The grant of Minority Community Educational Institute to the College is subjudice before the Hon'ble High Court, Delhi. The direction regarding reservations in vacancies, as received from UGC and University are followed


