**Sub:** Seeking Information under the RTI act, 2005

I seek the following informations:

- (1) Kindly provide me the names of the teachers appointed in permanent capacity in your college in the year 2004 or thereafter who were given the pensionary benefits under the old pension scheme and the benefit of the Provident Fund (PF) scheme on the basis of their temporary or adhoc experience prior to January 1, 2004 even if the PF deduction did not take place during their temporary tenure.
- (2) Did these teachers have to go through another selection process (in terms of appearing for an interview before the selection committee etc.) during their permanent appointment which took place on or after January 1, 2004? If yes, kindly provide me their date of joining as permanent faculty members.
- (3) Kindly let me know that whether the benefits of the old pension scheme and PF for such teachers were approved by the competent authorities of University of Delhi.

This has reference to your application dated 01.07.2014 seeking information under RTI Act 2005. The replies to your queries are given hereasunder:


1. The teachers, who were appointed against substantive posts after 2004, and have been given benefit of Provident Fund are
  - o Ms. Jasneet Kaur Wadhwa, Department of Economics
  - o Dr.(Mrs.) Savinder Kaur, Department of Physics

Both the above-mentioned teachers were appointed against temporary posts prior to 2004 on recommendation of duly constituted Selection Committees at the College. They were appointed against permanent posts in continuation of temporary appointment (without any break) on recommendations of duly constituted Selection Committee in the subject

2. Both the above-named teachers were interviewed by the Selection Committees which recommended their appointment against substantive posts. They were appointed against substantive posts w.e.f. 17.07.2006 and 12.01.2006 respectively
3. The University of Delhi vide letter no. CS-1/(111)/Misc.(TS)/SSC/(LY)/2014/220 dated 23.06.2014 has directed that the teachers be reversed and they may be put under New Pension Scheme
