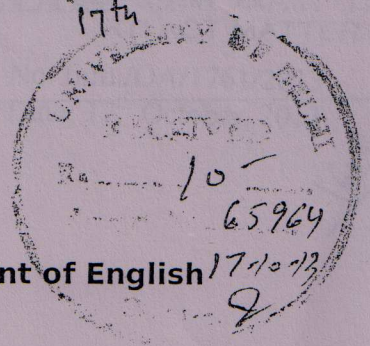

Information requested Under RTI related to Department of English

Dear Sir,

Kindly provide the following information under RTI Act. This is in relation to the appointment of Mr Kuljeet Singh, Assistant Professor (adhoc) in the English Department of S.G.T.B. Khalsa College. His name appears in category Vi of the July 2013 adhoc panel available on the University website.

1. Since when (which year) has Mr Kuljeet Singh's name been included in the Department of English, University of Delhi's adhoc panels?
2. At the time of inclusion, did Mr Kuljeet Singh hold a M.A. In English with NET in English, i.e. the requisite qualifications for becoming an Assistant Professor in English as per the University's norms?
3. if the answer to the above question is "NO", please give grounds of exemption with documentary proof of the same from the competent authority.
4. If exemption has been given, has the University been extending the same to other subjects of the University for the post of Assistant Professor.
5. Also, if the answer to Q3 is "NO" and relevant exemption orders were not granted, please give name of Head of Department and members of the committees who had prepared the adhoc panels over the years.

Reference your application dated 16/17 October 2013 seeking information under RTI Act. The available information to your queries is given hereunder:

1. The matter pertains to Department of English, University of Delhi because the adhoc panels for appointments as Lecturer re-designated as Assistant Professor on adhoc basis in each academic year are prepared by respective university departments. Sri Guru Tegh Bahadur Khalsa is not the competent authority to supply the information
2. In view of reply at 1, the Department of English, University of Delhi can supply the required information. As per the record with Sri Guru Tegh Bahadur Khalsa College, Mr. Kuljeet Singh, is M.A (Comparative Indian Literature), NET qualified in the same subject
3. It is submitted that Mr. Kuljeet Singh had taught as a Guest Lecturer in English at Sri GuruTegh Bahadur Khalsa College during academic year 2004-2005. The Convener, Department of English (Academic session 2007-08) recommended that Mr. Kuljeet Singh, M.A (Comparative Indian Literature), NET qualified in the same subject be appointed as Lecturer in English on adhoc basis to teach Courses in Indian Literature in Translation to the students of English as no one from the panel, prepared by the Department of English, University of Delhi was willing to join during mid of the academic session to teach the paper. Therefore Mr. Kuljeet Singh was appointed as Lecturer in English on adhoc basis on 12.11.2007 in the College to cater to the urgent and immediate needs of the students in the subject.
4. The matter pertains to the University of Delhi and the reply can be had from concerned department in the University
5. The circumstances under which Mr. Kuljeet Singh was appointed at Sri Guru Tegh Bahadur Khalsa College have been mentioned at point-3 above. The information pertaining to the query can be given by the concerned department in the University
