

## MINUTES

**Staff-Council held on 23<sup>rd</sup> May 2025, 12.15pm in the College Seminar Room.**

1. After the welcome of the new Chair, the Principal made his observations on the functioning of the College and where he would like to bring about changes:
  - a. We have not been able to finish our second round of NAAC accreditation.
  - b. With the coming of the 4<sup>th</sup> year, the College will have a space crunch. The College building is in urgent need of repair and white wash. Washrooms need to be repaired/ remodeled. The College will install a solar plant of (100 KW by August) once roof repairs are completed. Audi space will be optimized to ensure some class-rooms can be made and utilized there.
  - c. A new College website with ERP solution has been developed with the inputs of Prof. Satish Verma and the web-committee/ smart-prof portal committee.
  - d. There are too many societies and their numerous programs are affecting class-room teaching. Restrictions on the number of events must be implemented as soon as possible and the Calender Committee has to work in this direction.
  - e. Everyone should get a chance to work in a committee and the tenure of a person in a committee should be restricted. Senior faculty should take the responsibility to train the juniors for the next term. Also, the number of committees a faculty can be a part should be restricted (ideally a persons name should not appear in more than two committees).
  - f. Annual report is an important document of the College and should contain the information of research work done by the faculty. However, it has been noticed that faculty members are not forthcoming in giving their information.
  - g. The Principal expressed grievance in the manner in which some Departments have decided on the Teacher-in-Charge (TIC) for the next academic year. Senior faculty who were supposed to take up the responsibility by virtue of rotation as per seniority, refused and meeting's minutes do not record their reasons. Also, different Departments were holding their meetings at different dates and new TIC took over from April-June. This was having an impact on the College administrative work. The Principal requested all Departments to withdraw their decisions on TIC and allow the office to issue appointment letters to TIC based on seniority in College records. This would ensure that all new TICs could take charge from 1<sup>st</sup> June of the year.

The Secretary allowed for discussion on item (g). Prof. Bipin Kumar Thakur, believed the Department should be allowed to decide on the matter of TIC as per precedents. Mr. P. D. Sharma explained to the house that this was not just a matter of



precedence but decisions made in past Staff-Councils (1980-90s). He further informed that record keeping was also under the preview of the Department. Dr. Deepali Sharma and Prof. Pratibha Chawla agreed and implored that as long as the present method was working, no change was required. They also believed that administrative changes would decrease the flexibility of decision making by the Department. Mr. Amandeep Singh queried if there would be any adverse consequences if a person refused to take up the TIC position? The Principal cited examples of problems faced during promotions due to lack of records, and the lacune faced due to too much flexibility exercised by the Departments. Also, considering AC/ EC adoption of new method of deciding seniority, it would be better for the office to make appointments considering their holding of complete records.

Dr. Vimal Rarh urged the house to accept the Principal's suggestions since the TIC appointments were done as per a set rule of the University which did not give flexibility and considering it a routine matter, could be best done by the administration.

It was decided that

- if a TIC proceeds on leave for a period of more than a month, his/ her tenure would be passed on to the next in seniority.
- Any denial to take up the responsibility should be recorded in minutes with reasons.
- Departments in their next meeting should take up this matter for discussion and report decision before next Staff-Council.

Dr. Amrendra Kumar Pandey was of the belief that the Principal's suggestion should be accepted and the Staff-Council was a more appropriate body to make the decision, rather than the Departments. It was ruled that Department views can be taken and decision on this matter will be taken up in future Staff Councils.

Prof. Bipin Kumar Thakur demanded a Staff-Council should be held at the end of every semester as per the rules of the University.

2. The second agenda taken up was confirmation of the minutes of the last Staff-Council held on 11<sup>th</sup> Dec 2023. The minutes had been circulated by email in advance and hence was not read out. The following amendments were requested:

a) Prof. Rachan Kaur Sareen pointed out that the ICC incharge holds office for three years and is not a part of the Staff-Council. Accepting the error, the mention of ICC incharge in Appendix A and B of the minutes stands deleted.

b) Mr. P. D. Sharma suggested Appendix B should add a starred item stating committees which had only completed one year as on December 2023 would continue and is not listed above.

c) Prof. Bipin Kumar Thakur raised queries on item 5 and 7 of the minutes, where his name had appeared. While it was pointed out that



Prof. Nachiketa Singh who was in the chair (Staff Council Secretary) and is not present (now Principal, Shyam Lal College, Evening) had taken handwritten minutes and are not available. Prof. P. Arun, however, explained the recorded matter from his notes. Prof. Bipin Kumar Thakur accepted recorded points.

d) Prof. Bipin Kumar Thakur objected that letters of appointment to in-charge of various committees should not be issued by the Staff-Council Secretary. The Principal accepted the demand and decided henceforth letters would be issued by the Principal Office.

***With the above mentioned corrections, the minutes were adopted.***

3. Reports of various committees were circulated to the members via email and was placed for discussion. Prof. P. Arun, observed that some committees were found overstepping and infringing into the preview of other committees and this should be avoided at all cost. Prof. Sukhvir Singh requested that he may be given an opportunity to read his report. The Chair gave him permission. The house passed all the reports by voice vote.

Prof. Amanpreet Singh Gill thanked the Secretary for introducing transparency and for presenting Reports of various committees and work done by the committees in their tenure. He requested this should be a norm rather than an exception to which the Principal agreed to ensure presentation of reports in future too.

Prof. Bipin Kumar Thakur, insisted observations made by members while reports are being discussed (for that matter any suggestions) must be met with an action taken report in the following Staff Council.

4. Before the exercise of constituting various Staff-Council committees and electing their incharge, the Principal suggested that since only 18 months have elapsed since last Staff-council and by practice, incharges held office for two years, the house can decide if members would be allowed to continue for six months or if needed till 31<sup>st</sup> May 2026. Some Committee incharges reported that they would like to be relieved of their duties. Hence it was resolved that each committees name would be taken up one by one and present incharge would be asked if he/ she would like to continue. If affirmative, they would continue till 31<sup>st</sup> May 2026, else house would elect new incharge.

Principal also stated that anyone who had completed more than four years would/ should not be considered.

5. Prof. Gurinder Singh's name was proposed for the Staff Council Secretary by Dr. Nimmi Singh and seconded by Dr. Parminder Kaur Narang. On confirmation, Prof. Gurinder Singh was requested to join the chair on the dais.



6. After the proposal of Mr Ritwick's name for the Time Table/ Workload and IA Committee, Prof Sukhvir Singh raised a point that this is a critical committee and the College can ill afford an "experimentation".

Prof. Amanpreet Singh Gill observed that only people with domain experience should be made in-charge of this critical committee. He believed Mr. Ritwick Bhattacharjee, whose name had been proposed for the Time Table/ Workload and IA Committee lacked experience (remaining remarks expunged).


Mr Ritwick took exception to the member's questioning his ability.

Mr. P.D. Sharma objected and rejected the claim that the old software and its process was found wanting and lacked transparency. On the contrary, the software was robust and had the best policies of industry when it came to transparency, integrity and protection features. Information was 24x7 available to the College Principal office, Accounts and EDP room. In fact, even the Principal Office had not taken up a password and used its login. He expressed his anguish of a committee conducting a meeting which strictly came under the Internal Assessment (IA) committee.

Dr. Deepali Sharma, objected to fact that website committee was kept outside the preview of the Staff Council (Item 1 c) and under the pretext of website and ERP solution, exercise had been initiated for taking over the Time Table/ Workload and IA Committee, even before the Staff Council meet. Prof. Pratibha Chawla requested that the web committee should be bought under the Staff Council's preview.

Prof. Bipin Kumar Thakur, called for a division of votes for this Committee, however the Secretary pointed out, no object was raised on discussion of Item 4, hence it stands. Also, the fact is no second proposal had been made. Mr Ritwick Bhattacharjee was confirmed in-charge of Time Table/ Workload and IA Committee.

7. Appendix A and B record the voting related to various Committees and the incharge elected, respectively. Appendix C is attendance record.
8. Meeting ended with vote of thanks to the chair and request to incharge of various committees to give co-opted members of their committees at the earliest.




