## Facts:-

1. The Appellant, Ms. Kiranpreet Kaur has filed an Appeal against the reply of the Original Application (OA) No. 955 of 2011 before the Registrar & 1<sup>st</sup> Appellate Authority of the University under the Right to Information Act, 2005 (hereafter the Act). The Appellant states that she is not satisfied with the reply of the CPIO.
2. The Appellant, Ms. Kiranpreet Kaur had filed OA No. 955 of 2011 dated 14.07.2011 received by the CPIO, University of Delhi on 14.07.2011 seeking break-up of marks in project and other related matters. The CPIO replied to the OA on 27.07.2011.
3. On perusal of the reply of the CPIO, it appears that the CPIO has provided information to the Appellant on the basis of the input received from the Deputy Registrar (Results), who is the deemed PIO under Section 5(4) and 5(5) of the Act. The CPIO had also transferred the Original Application to the PIO, SGTB Khalsa College under Section 6(3) of the Act.

## Decision:-

1. After considering the Appeal, it is noticed that the CPIO has forwarded the information provided by the Deputy Registrar (Results) in this matter. The CPIO had also transferred the Original Application to the PIO, SGTB Khalsa College under Section 6(3) of the Act.
2. On perusal of the First Appeal, it appears that the College has not replied to the OA under reference. Therefore, the OA is required to be transferred to the Principal, SGTB Khalsa College for further appropriate action in this regard.
3. The appeal is decided accordingly.
