

This has reference to your application dated 27.06.2011 seeking copies of the documents under RTI Act 2005.

The replies to your queries are given hereasunder:

1. No letter dated 26.03.2010 was issued to Sh. Akhilesh Kumar
2. The minutes of the Selection Committee meeting dated 27.01.2009 being a confidential document cannot be supplied. However this is to inform that Mr. Akhilesh Kumar, a visually challenged applicant was offered appointment as Lecturer in English against a substantive post subject to passing NET or completing M.Phil within two years. The appointment and relaxation from having cleared the NET or completing M.Phil as the essential qualification was subject to approval of the University of Delhi and University Grants Commission. The University Grants Commission vide letter no. F.1-1/2—9(PS) Meeting Pt.file-I dated 16 March 2010 conveyed approval for exemption from NET in respect of Mr. Akhilesh Kumar. However the UGC vide letter no. F.1-1/2002(PS) Exemp.Pt.File IV dated 03 June 2010 addressed to 'The Vice-Chancellor, University of Delhi' withdrew the approval for relaxation from NET in respect of Mr. Akhilesh Kumar.
