

Sir,

This has reference to your application received at the college on 10th March 2011 seeking information under RTI Act 2005. The replies to the points in the application are given hereunder:

1. The College has not appointed a Liaison Officer for OBC category because the case of the reservation for OBC category is subjudice before the National Commission of Minorities Educational Institutions.
2. No model roster is prepared as the appointments have not been made in view of matter being subjudice before the National Commission for Minorities Educational Institutions.
3. The College has not implemented OBC reservation because the case of the reservation for OBC category is pending before the National Commission of Minorities Educational Institutions.
4. No permanent appointments have been made under OBC category
5. (a & b) The Dean of Colleges vide letter no. DC-2004/325 dated 16th August 2004 sanctioned permanent faculty strength as 150.
(c) No permanent appointments of teaching posts have been made since 2006.
(d) The number of vacant positions at this College is 31.
6. (a) 45 teachers are appointed on adhoc basis in the academic year 2010-11.
(b) No ad hoc positions were made in the OBC Category, however OBC candidates were called for interview for appointment on adhoc basis and were treated at par with general category candidates.
(c) No appointments have been made under OBC category.
(d) No, in view of the answer in pt. no. 6 (c) it is not relevant.
7. OBC category admissions are not made in view of matter being subjudice.

9. No fund was received under OBC expansion.
10. In view of the pending case before the National Commission for Minorities Educational Institutions (NCMEI) no new teaching positions were sanctioned.
11. The College does not have a separate panel of observers for OBC category; in view of the answer in pt. no. 10 it is not relevant.
