This has reference to your letter no. ARDP/RTIL/2011/65 dated 17 February 2011 seeking information regarding appointment of teaching staff under Physically Handicapped category under RTI Act 2005.

The replies to queries are given hereasunder:

1. The sanctioned strength of teaching is 150
2. 76 (Seventy Six ) appointments have been made against teaching posts since 1994
3. 03 appointments were made against handicapped category (02 OH, 01-VH)
4. The OH appointees were allotted points no. 24 and 37 in the old Roster
5. 01 candidate was appointed against VH subject to approval from UGC from exemption in NET
6. No appointments against the post of Reader/s
7. No appointments against teaching posts have been made since 2006 and no teaching post/s have been advertised since then
8. The reports of the Selection Committees cannot be provided in view of reply at point 07
9. No model roster is prepared as the appointments have not been made in view of matter being subjudice before the National Commission for Minorities Educational Institutions.
10. The direction regarding reservations in vacancies, as received from UGC and University are followed
