This has reference to your application dated 10 January 2011 received at the college on 13th January 2011 seeking information under RTI Act 2005. The replies to the points in the application are given hereunder:

The Dean of Colleges vide letter no. DC-2004/325 dated 16th August 2004 sanctioned permanent faculty strength at 150.

The sanctioned strength of the non-teaching employees is as per the guidelines contained in

Governance of Colleges, University of Delhi.

The institution follows the reservation policy (for Scheduled Castes and Scheduled Tribes) as per the instructions of Government of India, received through University Grants Commission and University of Delhi.

The College has been maintaining roster of Vacancies for teaching and non-teaching posts with reservation for SC and ST. However due to pending case before National Commission for Minority Educational Institutions regarding status of the College, the roster of vacancies have not yet been certified from University of Delhi authorities.

In view of the pending case before the National Commission for Minorities Educational 6. Institutions (NCMEI) the competent authority has still not given permission.

The current status would be known after approval by the competent authority.
