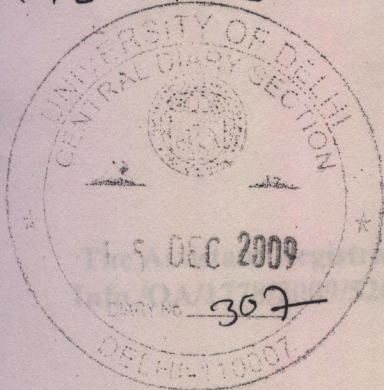

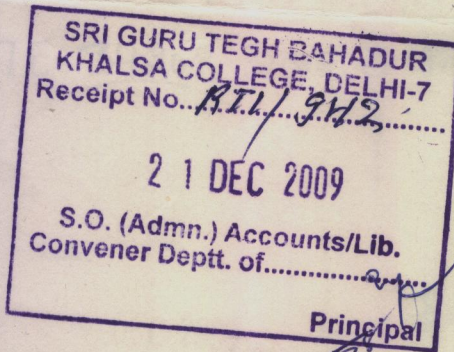
Sir/Madam,

Dear Sir,

This has reference to your request dated 14.12.2009 addressed to Public Information Officer, Delhi University, Delhi seeking information under RTI Act 2005.

The replies to your queries pointwise are given as under:

1. The provision for teaching of Urdu is not available at the College
2. Urdu, as an Hons. Course was never taught at the College
3. There are no permanent / adhoc / temporary teachers in Urdu at the College
4. There was provision for relaxation of marks at the time of admission to undergraduate courses to the students, who offer to study Urdu as one of the subjects. It is added that inspite of best efforts on the part of the institution, no students willing to study the subject have been approaching the College for admission for quite some time
5. No, It is added that inspite of best efforts on the part of the institution, no students willing to study Urdu as one of the subject approached the College for admission during the academic session 2009-10
