In response to the circular letter dated 09.02.2012 of the University relating to Study Leave availed by the College leachers, a number of cases have been referred to the University by the Colleges concerned for clarification/advice on settlement of the cases of leachers who did avail Study Leave but failed to complete their studies during the Study Leave period or re-join College on expiry of the Study Leave.

The matter has been examined by the University of an appropriate level and I am directed to convey that the Governing Bodies of Calleges may consider settlement of these cases in the following manner:

- a) The cases of leachers who are either unable to complete their studies or failed to re-join the Callege on the expiry of Study Leave granted to them till 2002 i.e prior to implementation of General Leave Rules, 2002 may be dealt with by the respective Governing Bodies of the Colleges of their own level in accordance with the conditions incorporated in the Study Leave Bond executed by them at that time of proceeding on Study Leave.
- b) The cases of teachers who have been granted Study Leave after 2002 i.e after the implementation of General Leave Rules, 2002, and who are either unable to submit their Ph.D thesis/complete their studies, within the period of Study Leave or have failed to re-join the College on the expiry of Study Leave, the Governing Bodies, after taking into consideration the circumstances and merit of individual
