who have studied Punjabi or who opt to study Punjabi as one of the subjects, as per the practice adopted by the Parent Body and communicated to the college, Governing Body and which normally is notified in the College prospectus

The information sought pertains to personal information. The RTI Act-2005, Chapter II, 8(1)(j) does not permit disclosure of personal information disclosure of which has no relationship to any public activity or interest or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be is satisfied that the larger public interest justifies the disclosure of such information. However the number of admissions on 27,07,2015 and 14,08,2015 is provided. (Annexure-II)

The information sought pertains to personal information. The RTI Act-2005, Chapter II, 8(1)(j) does not permit disclosure of personal information disclosure of which has no relationship to any public activity or interest or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be is satisfied that the larger public interest justifies the disclosure of such information. However the no. of students other than the Sikhs admitted on 27.07.2015 and 14.08.2015 is provided (Annexure-III)

Detail of Sikh Students and other students admitted in different courses on the recommendations of President, General Secretary and other members of Delhi Sikh Gurdwara management Committee and upto what percentage such admissions were given

The College having been declared a minority educational institution by the National Commission of Minority Educational Institutions of India, applicants belonging to Sikh Community, linguistic minority and those who wish to study Punjabi as one of the subjects are given suitable relaxation in the declared cut-offs, as resolved by the competent authority. Normally the information is also incorporated in College prospectus. (Annexure-IV).

The details of students by name pertains to the personal information. The RTI Act-2005, Chapter II, 8(1)(i) does not permit disclosure of personal information disclosure of which has no relationship to any public activity or interest or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be is satisfied that the larger public interest justifles the disclosure of such information. However the no. of admissions can be provided on request

Who has taken dharmik/Religious test of Sikh students and upto what percentage such admissions were given? Details of Sikh student admitted under this category (course wise)

A committee consisting of College faculty members and experts from outside, as per the guidelines of University of Delhi took the test of students, who had applied for admissions on the basis of extracurricular activities including Divinity. The relaxation of marks in the category was as per the guidelines of the University. The shortlisted candidates' list is attached, (annexure IV)

Whother Dharmik test taken by your college was written or oral ? Who was incharge of this test (name & designation)? Copy of result sheet prepared for admission of Sikh students under this category?

The test was oral and vocal in recitation. The Convener (Divinity Society) was the Incharge of the test. It is further informed that applicants belonging to all communities including Sikhs are eligible for admission under this category.

What is the criteria and parameters for the Sikh students to clear this test (Copy of the question

paper) to avail special relaxation in admission in different courses under this category?

The applicants seeking admission under extra-curricular activities (ECA) are supposed to pass the test as designed by the experts under different sub-categories including divinity. The criteria and parameters are as per the norms of the University.
