This has reference to your application dated 22 May 2015 which was received on 03 June 2015 at the College, seeking therein information under RTI Act 2005. The reply to your query is given hereasunder:

1. Dr.(Mrs.) Vaneeta Aggarwal, Associate Professor in Physics was sanctioned leave on medical grounds from 05.12.2012 to 04.01.2015
2. She joined on 05.01.2015 and submitted medical fitness certificate. On the day itself she made a request to proceed on Child Care Leave for two years which was not acceded to without the sanction of competent authority
3. In view of the Medical Fitness Certificate submitted by Dr. (Mrs.) Vaneeta Aggarwal after availing long leave on medical grounds and to serve the public interest i.e. interest of the students, the CCL was refused
4. Dr.(Mrs.) Vaneeta Aggarwal was unauthorizedly absence from duty since 06.01.2015 without sanction of proper leave

As per the Leave Rules - 2013 for Permanent University and College Teachers, University of Delhi the Leave of any kind cannot be availed as a matter of right
