SUB:- APPLICATION FOR SEEKING INFORMATION UNDER RTI ACT 2005 IN RESPECT OF SECURITY/HOUSEKEEPING AGENCIES STAFF ENGAGED IN YOUR COLLEGE

Sir,

- 1 I, Jeev Kant Jha, a social worker, am seeking some information and records regarding private security/housekeeping agencies staff engaged at your organization for ward and watch & housekeeping and outsource services under RTI Act 2005.
- 2 In view of the above, you are requested to provide following details of the security /housekeeping agencies as per provision of RTI Act 2005.
 - a. Copy of Work order and agreement of security/housekeeping agency working at your organization.
 - b. Copy of Salary and wages paid to guards /housekeeping Pvt. Staff for June & July 2014 of contract.
 - c. Copy of PF, ESI and Service Tax of challans & ECR (PF) paid by security/housekeeping Agencies for present contract at your organization for June & July 2014 of contract.
- 3 Since the matter of security/housekeeping/Manpower contracts are allotted through your organization having huge amount of Govt. organization are involved in this contract. Viewing this, I am of the opinion that the information being sought does not fall within the preview of section 8 & 9 of the RTI Act 2005. Further as per section-11(2) also state, any documents or information involving public expenditure cannot be considered as third party information, moreover any commercial agreement between a public authority and a third party being a public documents and there is no ground of commercial confidentiality therein. It is to be born in mind and PIO cannot refuse to disclose the information concerning a third party to protect private interest of the third party. (Copy enclosed)
- 4 It is learnt that some CPIO/PIO of Govt. organization are ignoring to provide information seeking under RTI Act 2005 stating "Information sought is exempted from disclosure under sec 8(1) and 8(J) of RTI Act 2005". The Chief information commission is seriously taking this type of excuse and has panelized some CPIOs while hearing of appeal in its honorable office.
- 5 I am a citizen of India by birth and I am eligible under Sec 3 of RTI Act 2005 to seek the above information. I enclosed herewith a postal order for Rs. 10/- towards RTI fees and documents charges please.


Dear Applicant,
