The names of the students, who have been admitted against the seats cannot be disclosed under RTI Act-2005, Chapter-II, 8(1)(j) because information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information:
- 2. 17 students took admission into the course after the first counseling, out of which 9 students changed their course/college in the 2nd or 3rd or 4th or 5th counseling.
