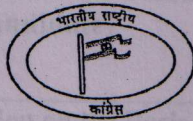

Hon'ble Sir,


My son, Mr. Abhishek Tyagi, was invited by Sri Guru Teghbahadur Khalsa College to appear in a Fitness Test. A photocopy of the invitation letter is enclosed for reference. He was asked to take part in 2 events namely (1) Standing Broad Jump and (2) 50 Mts. Dash. He had cleared both these events. Today was the date for trial in Hand Ball event on the basis of which selection was to be made for admission in Under Graduate Courses. Trial was at 9 O'Clock. The Coach, who was competent to take the trial came after 1 O'Clock. The formality was completed before the arrival of the Coach. It was just a formality and selection was made without any merit. The trial was taken by some students just for eye wash. It was quite clear the selection was made even before the trial took place. It was in most unfair manner. The students selected cannot stand in competition with my son. It can be proved if proper competition is carried out of the selected students with my son.

The way the proceedings have been carried out are most unfair. This discourages the deserving students. Hence I request your Honour to kindly direct the concerned authorities to declare the selection null and void and follow the right procedure for the selection of students for admission to the Under Graduate Courses.

Public Authority is represented by Dr Jaswinder Singh, Principal/FAA and Dr Ravi S.Bhattacharjee, Sports Convener and Shri Jarnail Singh, SrPA to the Principal.

FACTS

Vide RTI dt 28.6.13, appellant had sought information as to action taken on his letter dt 24.6.13 relating to irregularities in selection of students for admission under the Sports quota.

2. PIO vide letter dt 31.7.13 informed the appellant that his complaint dt 24.6.13 was referred to the appropriate Grievance Redressal Committee and a copy of the complaint was enclosed.

3. An appeal was filed on 26.10.13.

4. PIO vide letter dt 1.11.13 informed the appellant that in response to the RTI, a reply had been sent twice on the same issue.

5. Submissions made by the appellant and public authority were heard. Appellant submitted that in response to his appeal, he was provided a response by the PIO and not by the AA. Principal submitted that on occasions, the then PIO, being the senior most teacher also deputed as Officiating Principal.

DECISION

6. The Commission has considered the submissions made and finds that as per the provisions of the RTI Act, a response to the appeal should have been responded to by the AA and not the PIO himself. It is also found that the appellant has addressed his appeal dt 26.10.13 to the PIO, rather than to the FAA. The Commission directs the Principal, SGTB Khalsa College, to provide a written response to the appellant.

The appeal is disposed of.


Dear Sir,





Report of the Admission Committee regarding the said complaint.


The Admission Committee, for sports admission to SGTB Khalsa College took cognisance of the complaint and investigated the matter. The Admission Committee strongly denies any favouritism or irregularity in the conduct of trials and subsequent selection of students for admission in all games including Hand Ball. Marks out of 50 are awarded for past participations as per the Delhi University guide lines. Further, marks are awarded on the basis of performance of each candidate during the trials. These marks are out of a maximum of 50. This is done by a body of technical experts decided by Delhi University. Candidates are admitted strictly on merit keeping the specific requirements of the College teams.

According to the certificates submitted to the College, Mr. Abhishek Tyagi, son of Mr. Nardev Singh Tyagi, had only Zonal representation for which he was awarded 8 marks, as per Delhi University guide lines. A fair trial was conducted and based on his performance the concerned experts awarded him less than 18 marks, which makes him ineligible for selection.


The complaint, therefore, is devoid of any merit and is done with mala-fide intention to disrepute the College.






