



Sir, this is to submit that:


In the afternoon of 6<sup>th</sup> Sept., 2013, an untoward incident was occurred in the office of the Principal on the issue of withdrawal of nomination for Students' Union Election. After this, the relevant files, register and DDs etc. were taken from me by the Returning Officer, Dr. Bipin K. Thakur in the presence of Mr. Jarnail Singh, Sr. P.A., Mr. Paramjit Singh, Asstt., Mr. Amarjit Singh Chahal, Mr. Rishipal Singh, Mr. Jagdish and Mr. Vijay Shanker. I don't have any information about the further process.

I may add here that there are some points in the RTI, information of which can be given from the file in the office (with the dispatcher) but the Principal Sir, vide office order P/1402 dated 9.9.13 himself has unlawfully withdrawn the duties and responsibilities of Admn. Officer (offg) and has instructed the staff not to move any paper/s through the undersigned. Even the office file is not being moved through the undersigned for the last month.


Further, the telephone line at the seat of the undersigned has also been removed as per instruction of the Principal. On each and every seat, I have enquired; they are saying that the Principal has instructed them not to show any paper/s to the undersigned.

Sir, on the above pretext, I am feeling depressed, harassed and unnecessarily victimized.
