

Since no spare copy of tender document is available with the College, the copy of draft tender document can be procured from the architect after paying prescribed costs as specified by Public Information Officer.
- 6(b) The tender for construction of Science Block (Administrative Block) and Girls Hostel was awarded to M/s. Impact Buildcon, Gurgaon. Copy of the work-order is provided.

The University Grants Commission sanctioned Rs. 1 Crore, out of which Rs.90 lacs have been received from the UGC. The NCT of Delhi contributed Rs.25 lacs for construction of the hostel under the Delhi Kalyan Samiti Scheme. The UGC sanctioned Rs.2 Crores for construction of Science Block, out of which Rs.1.8 Crore have been received from the Commission. The rest of the amount used was from the College Development fund and other heads where the surplus fund is combined and used whenever required.
